使用方法

VpCI®-101使用极其简单便捷。该防锈海绵应尽可能早启用,最好在生产或组装过程中就使用。只要在任何一个密闭空间选择一个合适的位置,提前确保需要粘贴的表面是清洁的和没有碎屑的,撕去防锈海绵块的底部保护条,把胶面贴到一个选定的干净表面即可。VpCI®-101 防锈海绵可以安装在任何位置,对于大于1立方英尺(即28升)的空间,请使用多一个VpCI-101. 如果使用的空间非密闭,或者有经常开关的门,请提高VpCI-101的更换频率(少于2年)。经过大幅度的维修维护后,除了在密闭系统中少量喷洒VpCI-238或239外,还需要重换一个VpCI-101.
